## NOTICE TO SHAREHOLDERS

Dear Shareholder,

The board of directors of Danske Invest Allocation (the "Company") has resolved to adopt certain changes in the Company's current prospectus dated June 2017 (the "Current Prospectus").

The Board hereby would like to bring to your attention the major changes brought by the new prospectus of the Company dated November 2017 (the "New Prospectus") with respect to the presentation of the information, as follows:

## 1 Amendments to the Share Classes

The following amendments with respect to share classes have been added in the New Prospectus:

- adding of new base share classes P1, P2, P3, WI, ZA and ZI;
- change of current share class Y to share class SA;
- change of current share class YI to share class SI;
- the initial investment amount requirement has been reduced to EUR 100.000,- or such approximate equivalent amount in other currencies;
- removal of the wording on "commissions" for the share classes RA and RI which is a consequence of the insertion of the WA and WI share classes which are "clean" share classes and for which this "commission" wording has not been added as a consequence of the implementation of Directive 2014/65/EU ("MiFID");
- change of existing share class W to share class WA and amendment to the "fencing" wording;
- the reference to "alike" fees mentioned in the description of the WA share class has been inserted in order to cover fees charged by Danske Bank to their clients for services under execution only agreements, where such fees are not to be considered as advisory fees;
- insertion of a note for shareholders resident in Sweden having a discretionary investment management agreement with Danske Bank Group;
- the currency hedging limit has been amended from 90% to 95% in order to comply with ESMA opinion on share classes of UCITS (ESMA34-43-296).

# 2 Investment Horizons

For the purpose of aligning the investment horizons with the standard use within the Danske group, the investment horizons have been changed (they have mainly been decreased) for the following Sub-Funds:
