## Danske Invest Allocation

This fund is managed by Danske Invest Management A/S, a subsidiary of Danske Bank A/S.

#### Objectives and investment policy

##### Objectives

The objective of this fund is to achieve medium-term investment growth, while applying a defensive asset allocation strategy. The share class is accumulating.

##### Investment policy

The fund is a feeder fund, and invests at least 85% of its net assets in class X shares of a master fund, Danske Invest SICAV Global Portfolio Solution - Stable.

The fund may use derivatives only for hedging, such as to hedge some or all of its holdings in the master fund, and the master fund's investments, into DKK.

The master fund gains exposure, directly or indirectly through other funds and derivatives, to a range of asset classes from anywhere in the world, such as equities, bonds and money market instruments. The fund may gain exposure to any credit quality, sector and country, including emerging markets. The fund seeks to maintain a volatility level between 2% and 5% and could be tilted towards fixed income.

The fund is categorized under SFDR as article 8 and promotes environmental and/or social characteristics, as well as good

governance practices, through screening, restrictions, investment analysis and decision-making as well as active ownership. The fund follows Danske Invest's responsible investment policy.

In actively managing the master fund's portfolio, the management team applies a flexible and dynamic asset allocation (including both strategic and tactical asset allocation) that seeks to take full advantage of market changes and opportunities. The master fund may use derivatives for hedging and efficient portfolio management, as well as for investment purposes. The master fund may invest in Chinese A-shares subject to quota and operational constraints, which may increase legal and counterparty risk.

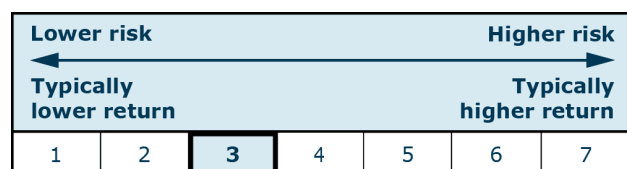
The fund's performance does not fully match that of the master fund due to, in particular, the fund's costs and expenses, its potential use of derivatives and a difference in base currencies.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

##### Benchmark

The fund has no benchmark.

#### Risk and reward profile



The fund is categorized as 3. The indicator illustrates the typical correlation between the risk and your potential return of the investment. The categorization is determined by the fluctuations in the fund's net asset value over the past five years and/or representative data.
